



Pool Rules and Regulations 2023

Authority

The Directors of McFryeVo Three LLC. created the following rules and regulations for Copper Cove Golf Club. Such rules and regulations are subject to amendment, as the Board of Directors of McFryeVo Three LLC deem necessary.

Hours of Operation

- The hours of operation have been set by management and they reserve the right to change the hours and/or close the pool should the Board deem it necessary. Hours of operation will be Monday-Saturday 10 AM -7 PM and Sunday 12 PM-7 PM. **The hour of operations for the grille will be from 10 AM to 6 PM each day. The grille will stop taking food orders at 5:30.**

Guests of Members

- Members may bring guests for a \$10 fee as long as the member is responsible for the conduct of his or her guest(s).

Conduct

- Children must not be left on the premises without parental supervision. Employees of the Club shall not be responsible for the children of any member or guest.
- No member shall interfere in the operation or management of any facility or amenity within the Club. No member shall reprimand any employee of the Club.

Pool

- **No outside food or beverages allowed on Copper Cove property this includes but not limited to the pool area, parking lot, clubhouse grounds, and clubhouse. Only food and/or beverages from Copper Cove Grille are allowed.**
- **The pool area is considered a non-smoking area. This includes cigarettes, cigars, and vapes.**
- Use of the swimming pool shall be for members and their guests only. All members/guests must be signed into the guest book provided and pay applicable guest fees. Guest(s) must accompany the member.
- **It is imperative that everyone sign in and pay any appropriate guests fees upon entering the pool.**
- Bathing suits shall be worn in pool area only. Cutoff shorts are not allowed. **No one is permitted in the clubhouse in swimming attire.**
- On-duty lifeguards are employees of the club and are available to ensure the safety of all members/guests. For the safety of all patrons of the pool, lifeguards are not to be designated as babysitters for any members/guests or children. Parents must accompany their children under the age of (16) sixteen or have another responsible adult present with the child other than on-duty club personnel. This includes babysitters who have been added to the membership.
- All persons, including children, will use the pool and its facilities at their own risk. The Club is not responsible for any actions, any accidents, or injuries in connection with such use.
- The Club will not be responsible for lost or stolen articles. Management recommends that valuables be left in a secure place. Possessions should not be left on furniture in the pool area unless occupied by the owner of the possessions. The Club has no facilities for storing personal articles or furniture of members. Please take these items with you when you leave pool.
- Abusive language is not permitted. Boisterous conduct, rough tactics, running, or shoving will not be permitted.
- Animals are not permitted in pool area. Glass containers are not permitted in the pool area. Radios are permitted if volume is turned low, not to disturb others.
- Members may not reserve exclusive use of the swimming pool without the consent of the Club Manager. Such requests shall be made in writing to the Club Manager no less than 15 days in advance of the planned event.
- The Club will in no way be responsible for any accidents occurring in the area during any special function. The Club reserves the right to refuse use to any member if the function in any way interferes with the Club's operation or the endangerment of the Club's liquor license.

Alcoholic Beverages

- Copper Cove Golf Club has a wine, beer, and mixed beverage license. All members and guests must abide by the rules and regulations of the Alcohol Beverage Board.
- Wine, beer, or mixed beverages may not be brought on the premises of the Club. Wine, beer, and mixed beverages may be purchased and consumed in the grille, poolside and at planned parties.
- All members and their guests are responsible for their actions when consuming alcoholic beverages, and care should always be taken to keep consumption within reason. McFryeVo Three LLC, will in no way be responsible for any actions arising from any alcoholic beverages consumed at the Club, whether on the premises or apart from the Club.

Assumption of Liability, Waiver and Release

Neither the Club, McFryeVo Three LLC, nor their respective directors, employees, nor agents shall be responsible for the conduct of or liable from injuries, losses or damages suffered to persons or property arising from the use of the Club by members, their family members and guests. Each member agrees to indemnify and hold the Club and McFryeVo Three LLC, and their respective directors, employees, and agents harmless from all claims, suits, losses and expenses, including attorneys' fees, arising from the use of the Club by the member, his or her family members and guests. We acknowledge that the Club will, to the best of its ability, staff the pool with a certified lifeguard but that there will be times a certified lifeguard may not be available. Therefore, neither the Club, McFryeVo Three LLC, nor their respective directors, employees, nor agents shall be responsible for or liable from injuries, losses or damages suffered to persons or property arising in the absence of a certified lifeguard.
